This letter has been prepared in response to your February 2, 2017 letter to the Defense Logistics Agency Energy (DLA-Energy) and SFPP, L.P. (SFPP) requesting a revised human health risk assessment (HHRA) for the eastern 15-acre parcel of the Defense Fuel Support Point Norwalk, located at 15306 Norwalk Boulevard, Norwalk, California. In the letter, you requested that DLA-Energy and SFPP submit the revised HHRA by March 15, 2017. As discussed during a teleconference call with you and the other stakeholders on March 8, 2017, the submittal date for the revised HHRA was extended to March 31, 2017 to account for delays associated with inclement weather. This letter serves as SFPP's formal request to extend the submittal date for the revised HHRA to March 31, 2017.
