The Defense Logistics Agency (DLA) Energy and Parsons have received your August 10, 2011 letter, *Approval of Workplans for Light Non-Aqueous Phase Liquid (LNAPL) Characterization and Vapor Monitoring Program*. We appreciate your response to the report and workplans that have been submitted for the LNAPL and vapor monitoring program scopes of work. This letter will confirm and acknowledge our position on your letter.

In item number 1 identified in your August 10th letter, DLA will conduct an LNAPL recoverability study and subsequently refine the existing conceptual site model with updated data. However, due the current demolition and on-site construction activities being conducted at the Norwalk site, we are delayed in LNAPL investigation workplan(s) execution. Therefore, it would be very difficult to meet the October 30, 2011 date you have requested in the letter for the LNAPL report submittal. We would like to propose December 30, 2011 as the new date for the LNAPL investigation report.

For item number 2 in your letter, the first semiannual 2011 vapor monitoring report was submitted on August 29, 2011.

We await your response to this letter confirming that the LNAPL investigation report can be submitted by December 30, 2011. If you have any questions please call me at (602) 734-1083.
