In reference to the subject National Pollutant Discharge Elimination System (NPDES) permit, no discharge occurred during the second quarter of 2021. As such, this letter will serve as a "zero-discharge report" for this reporting period.

On February 23, 2021, the Kinder Morgan, Inc. (Kinder Morgan) product recovery and groundwater extraction (GWE) system was deactivated, and effluent discharge was discontinued. The GWE system shutdown is part of the overall site management strategy to temporarily suspend all hydraulic control activities for the purposes of evaluating alternative treatment remedies, as approved by the Regional Board Caseworker, Paul Cho, in an email on January 20, 2021. Other treatment remedies remain active at the site, including horizontal biosparging, vertical soil vapor extraction (SVE), horizontal SVE, and natural source zone depletion (NSZD). The Second Quarter 2021 Remediation Progress Report for the SFPP Norwalk Pump Station, submitted to the Regional Board on July 15, 2021, provides additional information about site activities during this reporting period.
